## POLICIES AND WAIVERS

**DEPOSIT/REGISTRATION:** Please mail your completed application with a deposit of \$250.00 per camper as part of total fee. Upon receipt of application and deposit, your child will be registered for camp. Applications will **not** be processed for registration without a deposit.

**PAYMENT POLICY:** The balances of camper fees, including the camp store account, are due May 21, payable to Camp Winfield. If the final balance is not paid by the due date, payment must be made in cash upon arrival. Health forms are due one month prior to the beginning of camp.

**REFUND AND CANCELLATION POLICY:** The deposit is non-refundable unless cancellation occurs 30 days prior to the beginning of the session for which the camper is registered. A \$15.00 processing fee will be deducted from all refunds due to cancellation. In the event of an early withdrawal due to illness, a refund will be given for the remaining days of the session. There is no deduction for late arrivals. All campers are expected to follow the rules of conduct for our camp program. The use of tobacco, alcoholic beverages, and/or illegal drugs is forbidden and cause for dismissal without refund. Campers with emotional or behavioral conditions, which are disruptive to the camp program, as determined by the Camp Director, will be dismissed without refund of fees.
